As a coach I fully appreciate the influence I will have on the children assigned to my WCYAA Youth Sports team. I also recognize that WCYAA Youth Sports values the instruction of skills and good sportsmanship over the issue of win-loss records.

I hereby agree, therefore, to be a model of decorum and good sportsmanship in all of my coaching activities, including interaction with officials. I agree to show respect to all of my players and to endeavor to teach them to respect each other. Above all, I agree to keep the goal of winning in perspective; and I shall never appear, in my actions or my words, to seek to dominate an opponent. I further agree to abide by WCYAA Youth Sports Rules of Play and Facility Use Regulations and never to manipulate them to my team's advantage. I also agree to follow all directions of WCYAA Youth Sports officials and supervisors. I agree that I will, if required by WCYAA Youth Sports and at its expense, become certified in Basketball by the National Youth Sports Coaches Association as a condition of selection as a coach and that I will abide by its "Coaches' Code of Ethics". I understand and specifically agree, as a material condition of my selection as coach, that the WCYAA Athletic Director in his sole discretion the right of approval concerning my appointment or reappointment as a coach and that I may be suspended or dismissed as a coach if in his sole discretion finds it would be in the best interests of WCYAA Youth Sports.

I will agree to abide by all WCYAA rules and policies WCYAA Code of Conduct, and the directors of WCYAA officials. I understand that to coach, I must be accepted by the WCYAA Athletic Director and complete NYSCA Certification in Basketball.
